



PERMISSION TO TRAVEL UNACCOMPANIED MINORS

Please read this carefully before filling out this form:

ENTERING THE UK

Other than their own valid travel document (passport), normally no particular extra official authorisation is required for minors of any EU country to enter or leave the United Kingdom, as they enter with an automatic visitor visa.

Children from countries outside the United Kingdom and the EU may need a visa in addition to their valid travel document, depending on their country of origin. This is the responsibility of the parents.

Regardless of your country of origin, we strongly recommend that you print out the Acceptance Letter and fill out our Permission to Travel form, in order to prevent any delays at border control. Please have your child carry both documents in addition to their Passport. Remember that any further permissions/ airline forms or similar, for unaccompanied minors, as well as visas, locator forms etc, are **the families' responsibility**.

LEAVING YOUR COUNTRY OF ORIGIN

Your country of origin may require that you provide ADDITIONAL documentation in order to be granted exit, for minors. For instance, some countries might require that the Permission to Travel form is signed and certified by the public notary, diplomatic mission or consular office, or require other relevant forms (such as in France and Spain, where UM's must travel with a specific police permission form.

It is your responsibility as a parent / legal guardian to make sure that, at the time of travel, your child has in their possession any required documentation. If you need us to send you any additional documentation to this effect, please do not hesitate to contact us. We shall send it to you promptly. We do not however take responsibility for children who are denied exit in their country of origin / entry in the UK for lack of documentation.

COMPLETING AND SIGNING THIS TRAVEL PERMISSION FORM

For your convenience, we have put together the Permission to Travel form. Please complete the blank spaces with the relevant information and circle the right options when necessary.

Please make sure that all those with parental responsibility sign the Permission to Travel. Unless one of the parents have sole legal or physical custody of the child, both parents need to sign it, regardless of their marital status.
